Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Nazim, Village Council Nagri Totial I, Tehsil/District Abbottabad's Tender Notice for Miscellaneous Works.

Dear Sir,

This is with reference to Village Council Nagri Totial I, Abbottabad's Tender Notice published in daily "Aaj" on 31st December, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, 15 days of response time is not given and the last date for submission of bids is given on 11-01-2016, which is 3 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

(1) Tender form and BOQ. can be downloaded up to one day prior to the opening date from LG&RDD website (www.lgkp.gov.pk) Interested contractors are instructed to obtain user name and password from his own enlistment / registration No for downloading of tender form and BOQ from the website.

(2) 2% earnest money in the shape of deposit at call, issued by schedule Bank of KPK for each work in the name of Nazim VC Nagri Totial I Attd must be accompanied with the tender documents.

(3) The contractor who offer/ quoting the rate 10% below on the engineering estimate/ BOQ shall attached additional earned money with the bid @ %age ratio of the offer rates as "below" otherwise the bid shall be treated as rejected and 2% earnest money already deposited will be forfeited and of should be made to the 2nd lowest, 3rd lowest as the case may be.

(4) Attested photocopy of CNIC valid registration with Pakistan Engineering Council, Director General LG&RDD and national income tax certificate be attached with tender documents.

(5) Sealed bids in original to the undersigned and a duplicate copy to shall be sent through register mail/ courier service which must be reached in the office of the undersigned before the prescribed time mentioned above. The bids received late shall not be entertained any delay in delivery of tender documents will be the responsibility of the bids.

(6) The cost estimate of works prepared on MSR-2016 contractor should quote their rates in figures as well as in words in the respective columns, also only the first two figures after decimal of the rates will be considered during evaluation of the bids. In case of blank columns the contractor shall be bound to execute that particular item free of cost.

(7) In case of totaling the amount worked out by the contractor found incorrect his bid will be rejected and deposited earnest money will be forfeited.

(8) In case bids become tie, the award of contract shall be decided through a free toss which shall be binding and final.

(9) Any disfigure/ over writing manipulation in the tender documents will not be acceptable.

(10) The procuring entity may reject any or all the bids after communicating the reason for rejection at any time prior to the award of contract.

(11) If any of the documents found not attached with the tender documents the tender shall be liable to rejection.

(12) The work order shall be issued against the volume of funds available with VCs/NCs during current financial year 2016-2017 for VCs/NCs ADPs scheme.

(13) Other term and condition can be obtained from the office during working hours or can be downloaded from the department.
