Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Executive Engineer, C&W Highway Division, Swat's Tender Notice for Miscellaneous Works.

Dear Sir,

This is with reference to C&W Highway Division, Swat's Tender Notice, published in daily "Express" on 1<sup>st</sup> July, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

Only the bid closing date & time is mentioned in the advertisement, without stating the date and time of opening of bid that shall be on the same day. Therefore the advertisement is in a violation of KPPRA Rules 2014, Rule No.37 (3). Stated as under;

*37. Submission of bids and bid opening: — (3) The procuring entity shall issue the bidder with a receipt showing the date and time when the bid was received.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
