Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, CEO/Secretary, KP-BOIT/ Tourism, Sports and Cultural Department, Peshawar's Expression of Interest/ Pre-Qualification Notice of Investors for Chairlift Resort at Naran-Lake Saiful Maluk.

Dear Sir,

This is with reference to KP-BOIT/ Tourism, Sports and Cultural Department, Peshawar's EOI/ Pre-Qualification Notice, published in daily "Aaj" on 30th June, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, the PQDs fee is given as PRs 50,000/- (non-refundable), which appears costly in light of the Procurement Rule and is violation of KPPRA Rules 2014, Rule No.36 (2). Stated as under:

36. Pre-qualification process.--(2) The procuring entity shall provide a set of pre-qualification documents to any contractor or consultant, on request and subject to payment of document fee if applicable, which shall not exceed cost of printing and providing the documents.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the EOI/ pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.
