Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, PSP, Additional IGP/ Commandant Frontier Reserve Police, Peshawar's Tender Notice for Supply of Feeding Charges.

Dear Sir,

This is with reference to Commandant Frontier Reserve Police, Peshawar's Tender Notice published in daily "The News" on 1st June, 2017. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, no information regarding issuance of bidding documents is given for the bidders. Therefore, the advertisement is in a violation of KPPRA Rules 2014, Rule No.33 (5). Stated as under:

33. Bid solicitation documents. (5) Solicitation documents shall be made available to the bidders from the date of their issuance to the closing date on submission of required fee by the prospective bidder whether in person or if so requested through an authorized request in writing. In case the request is made through courier, it shall accompany a bank draft in favor of the procuring entity including the cost of return delivery.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

The Supply of Feeding Charges would be checked on any working day. Detail of feeding Charges are as under.

1. Dry crashed Maize (Duar - without water) 9.072 KG and green gram 22 KG per Horse.
2. Crushed gram 1.361 KG
3. Chikar 1.134 KG
4. Duly thrashed gram (Dalya) 2.040 KG
5. Salt 0.028 KG
6. Hayrick 1.361 KG
7. Iron Clip for the legs per horse once in a month [Quantity 4 No's]
8. Hair cutting per horse once in a year.
9. Cost estimate about Rs. 50,00,000/-

Conditions:

1. Every item of the ration shall be mentioned separately.
2. In-Complete tender will not be entertained.
3. Grinding machine will be the property of their own bidder.
4. The following documents duly attested must be attached with the tender
 - i. Income Tax Certificate
 - ii. Five years experience Certificate of Feeding Supply for horses with any Govt. Deptt.
5. Contract duration is to be from 01-07-2017 to 30-06-2018.
6. Call Deposit 4% should be attached with the Tender in the name of Add: IGP/Commandant FRP HQs: Khyber Pakhtunkhwa, Peshawar.
7. If the Bidder refused from the given amount mentioned in the tender, will be consider black list and his Advance payment/Call deposit should be stand confiscated.
8. The dependents with regard to approval of Contract will not be relied on low rates, the experience of Tender owner and the financial stability and previous performance will be considered.
9. Income Tax should be deducted from all items under the existence rules.
