Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Superintendent, Judicial Lockup, Tank's Tender Notice for Supply of Cooked Food and other Miscellaneous Articles.

Dear Sir,

This is with reference to Judicial Lockup, Tank's Tender Notice, published in daily "The News" on 31<sup>st</sup> May, 2016. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per the advertisement, "Inspector General of Prisoners Khyber Pakhtunkhwa and Members of the said Committee reserve the right to reject the tender of any contractor/firm wholly or partially without assigning any reasons". Therefore, the advertisement is in a violation of KPPRA Rules 2014, Rule No.47 (1). Stated as under;

***47. Rejection of bids:-** (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Tender forms alongwith prescribed schedule of the required items can be obtained from the office of the superintendent Judicial lockup Tank till 14.06.2016 on any working day(except holidays) during office hours on cash payment on Rs.500/- Five Hundred (Non refundable). Cooked food & other articles will be supplied to the gate of judicial lockup Tank during the financial year 2016-17.

**Note.**

1. Tender forms alongwith schedule of required items duly completed in sealed cover will be submitted to the superintendent Jail office Tank before 11:00 AM on 16.06.2016.
2. Tender will be opened on the same day in the Superintendent Jail Office Tank at 11:00 AM in the presence of members of the committee constituted by Home Deptt: KPK & Tenderer / Their authorised representatives.
3. The concerned firms / contractors will submit earnest money amounting to Rs.100000/- in the shape of call deposit in the name of superintendent Judicial Lockup Tank at the time of collection of Tenders form. In the absence of earnest money, no Tender form will be issued.
4. Income Tax, Sales Tax, Professional Tax, Stamp duty etc or any other Tax levied by the Govt. will be deducted from the bills of contractors / suppliers in the ordnance with the rules / policy.
5. Inspector General of Prisons Khyber Pakhtunkhwa and Members of the said Committee reserve the right to reject the Tender of any contractor /firm wholly or partially without assigning any reasons.
6. Final approval of contract will be accorded by the Inspector General of Prisons Khyber Pakhtunkhwa.
7. In case of failure in supply or supply of substandard items or failure to abide by the rules / terms and conditions of contract, the concerned contractor / supplier will be blacklisted and his earnest money / security will be forfeited to the state besides levying of fine.
