Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Additional Inspector General of Police, Central Police Office, Police Department, Peshawar's Tender Notice for Solar System.

Dear Sir,

This is with reference to Central Police Office, Police Department, Peshawar's Tender Notice published in daily "Express" on 27th October, 2015. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per advertisement, "only the date & time of opening of bids is mentioned in the advertisement, without stating the last date & time of submission of bids that shall be on the same day". It is a violation of KPPRA Rules 2014, Page 18 & 19. Stated as under;

*Submission of bids and bid opening: — (3) The procuring entity shall issue the bidder with a receipt showing the date and time when the bid was received
(6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.*

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned in KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Mis-procurement.— Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.

Khyber Pakhtunkhwa, police Department invite sealed invite sealed tenders based on the khyber Pakhtunkhwa Public Procurement of Goods, Works & Service Rules 2014 from prequalified bidders/firms having previous experience as well as registered with income Tax and Sales Tax Departments, for Financial Year 2015-16. Tenders should be addressed to the Addl: IGP/Headquarters, Government of the Khyber Pakhtunkhwa Police Department, Peshawar. Technical proposals will be opened at 11:00 hours on the dates as noted against each, in the presence of Tender Evaluation Departmental Purchase Committee and intending bidders in Conference Room CPO, Khyber Pakhtunkhwa Peshawar. The delivery period will be 90 days or as per contract agreement.

1. The specifications/Tender documents pertaining to the above mentioned items can be obtained at a cost of Rs. 500/- (Non-Refundable) from the office of the DIG/Finance & Procurement, Khyber Pakhtunkhwa CPO, Peshawar on the submission of application on the firms letter head on any working day during office hours.

2. TERMS & CONDITIONS:-

The following terms and conditions shall apply:

i. Only the Firms/Suppliers Prequalified and already registered with Sales Tax / Income Tax Department can participate. Non pre-qualified/registered firm will not be considered. The Firms/Suppliers will also produce the invoice wherein the amount of Sales Tax has been shown.

ii. The offers shall be accepted only with original bidding documents. Photocopies will not be accepted.

iii. Each firm shall submit a sample on the date of opening of technical proposals.

iv. Each bid shall comprise a single sealed package containing two separate envelopes as under:-

Technical Proposal (Details of specifications, make, country etc. on the firm's letter head pad alongwith catalogue & bidding documents for respective item and submission of an Affidavit on Judicial Stamp Paper that 2% Earnest money CDR / Pay order is attached with Financial Proposal).

Financial Proposal (Rate of respective item including all taxes/charges whatsoever as per following form on the firm's letter head pad along with 02 % earnest money).

v. The envelopes should be marked in bold letters as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" respectively with name of item.

v. Technical proposals will be opened on above mentioned dates at 11:00 hrs: while Financial Proposals shall remain (in sealed form) in the custody of the Police Department and would be opened in the presence of bidders after receipt of the technical report.

vi. The bidders shall submit earnest money with their financial proposals noted against each item in the shape of CDR / pay orders of any scheduled bank in favour of the Inspector General of Police, Govt: of the Khyber Pakhtunkhwa, Police Department Peshawar. In case of non-acceptance of tenders, the earnest money will be refunded after finalization of the tender.

vii. In case of acceptance of tenders, the bidders shall deposit a security @ 10% of the total value of stores in the form of Call Deposit in the name of the Inspector General of Police, Govt: of the Khyber Pakhtunkhwa, Police Department Peshawar and sign the contract agreement with Police Department within 15 days of the issuance of the acceptance letter. Security shall be refunded as per term and conditions of agreement.

viii. The Items shall be received in the Centralized Godown CPO at Malik Muhammad Saad 'Shaheed Police Lines, Peshawar. No other destination shall be acceptable. Items shall be physically inspected by Inspection Committee constituted by competent authority and thereafter operationally tested at the post of contractor in Peshawar only. Items found not according to the standard specifications, will be rejected at the cost of contractor and may also result in forfeiture of security and black listing of the firm.

ix. Rates quoted would be considered only if the same are in Pak Rupees and inclusive of all taxes/duties/charges and inclusive of packing/freight till delivery to the Centralized Godown CPO & Centralized Kot at Malik Muhammad Saad Shaheed Police Lines, Peshawar. Rates shall be valid up to 30.06.2016.

x. Conditional tender/application will not be entertained.

xi. All taxes will be deducted as per existing government policy.

xii. The procurement entity may reject all bids or proposal at any time prior to the acceptance of bids or proposal. The procuring entity shall upon request communicate the grounds for rejection of all bids or proposal to any contractor or consultant who submitted a bid or proposal.
