1. The testing agency must be registered with FBR, have a valid NTN and should be registered with the Securities and Exchange Commission of Pakistan (SECP).
2. The testing agency/ firm should have a minimum of 5 year experience in conducting such tests/examination at a large scale.
3. The testing agency/ firm should have been providing the examination services to renowned public sector Departments/ Autonomous bodies/ Corporations/ Authorities etc. (A list of minimum of 40 such clients along with the no. of applicants must be attached with the EOI)
4. The testing agency/ firm should have established infrastructure for the purpose and the blend of manual/ computerized testing/ examination system and online facility of applying/ roll number issuance/ result declaration etc.
5. The testing agency/ firm should be financially sound (Financial statements of the last 5 years must be attached with the EOI)
