**Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Executive Engineer, Bannu Canal Division, Bannu's E-Tender Notice for Installation Works and Provision of 1 No. Solar Irrigation Tube Well.**

Dear Sir,

This is with reference to Bannu Canal Division, Bannu's E-Tender Notice, published in daily "Aaj" on 29<sup>th</sup> Sep, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per advertisement, 15 days of response time is not given and the last date for the submission of tenders is on 10-10-2017, which is 3 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

*13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Tender forms and BOQ can be downloaded from now till one day prior to opening of the tenders from Irrigation Department website [www.irrigation.gkp.pk](http://www.irrigation.gkp.pk).
- The bids will be processed in light of the minutes of meeting conveyed vide Chief Ministers Secretariat letter No. SOVI/CMC/KPK/1-13/2016, dated 08/04/2016.
- Earnest money shall be deposited in shape of "Deposit at Call" @ 2% of the estimated cost from any schedule Bank in Khyber Pakhtunkhwa, in the name of the undersigned and be attached with application in original.
- Tenders will be based and processed on "Above/Below" on BOQ basis and the bidders/contractors shall quote their rate accordingly in the tender form and BOQ.
- As per KPPRA Notification No.KPPRA/M&E/Est./1-5/2016, dated 24/05/2016. The contractors/bidders who quote their bids/rates more than 10% below the Engineer's estimate shall submit an additional security in the form of call deposit equal to 8% of the bid cost. (Which amended vide KPPRA No. KPPRA/M&E/Est./1-5/2016, dated 06/06/2017 Additional security in shape of call deposit equal to 8% of the estimated cost. Such bids if not accompanied by the Additional security will be considered as non-responsive and the next lowest bid will be considered.
- Only the first two (02) figures after decimal of the rate will be considered during evaluation of the bids.
- Tender Forms/bidding documents shall be issued to the original contractors/firms or their/his authorized agent (through a stamped paper of value Rs. 30) on the production of Original or attested copies of Registration/Enlistment, fee receipt, renewal fee receipt for the year 2016-17 and valid license from the PEC in the relevant category.
- Sealed bids shall be sent through registered mail/courier unsealed bid shall be rejected.
- All Taxes etc: shall be deducted from the bill of the contractors/firms at prescribed rate notified by the Government from time to time.
