Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Nazim/ Secretary, Village Council, Khudraizi, Tehsil Pabbi, District Nowshera's E-Tender Notice for Construction & General Cleanliness.

Dear Sir,

This is with reference to Village Council, Khudraizi, District Nowshera's E-Tender Notice, published in daily "Aaj" on 29th August, 2016. It is observed that the advertisements are in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per the advertisement, 15 days of response time is not given and the last date for submission of bids is given on 06-09-2015, which is 6 days short. It is a violation of KPPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
