Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Dean, PICO, Hayatabad Medical Complex, Peshawar's Tender Notice for Procurement of 30 Seats Students Buses.

Dear Sir,

This is with reference to PICO, Hayatabad Medical Complex, Peshawar's Tender Notice published in daily "Mashriq" on 25<sup>th</sup> December, 2015. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for submission of bids is given on 05-01-2016, which is 3 days short, and is violation of KPPRA Rules 2014, Page 18, the 'Response time' Clause. Stated as under:


***Response time.**---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.*

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

***Mis-procurement.**— Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.*

Qualified Firms, shall submit the Bid Security in an envelop alongwith the financial bids in the shape of Pay Order (PO)/Demand Draft (DD)/Call Deposit Receipt (CDR) equal to 2% of their bid amount; the name of Dean PICO HMC Peshawar, Khyber Pakhtunkhwa. The bidders shall submit an undertaking in their Technical Bids that the requisite Bid Security is included in their Financial Bid. Late bids will be treated as non-responsive.
6. The Bidders are requested to give their best and final price with Taxes for the quoted Buses as per the Specifications in Part-Two: Section-IV of the Standard Bidding Documents as no negotiations on the price are allowed. The bid must be valid up to 30.06.2016.

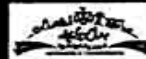
