Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Executive Engineer, Marwat Canal Division, Bannu's E-Tender Notice for Solarization of Irrigation Tube Well.

Dear Sir,

This is with reference to Marwat Canal Division, Bannu's E-Tender Notice, published in daily "Aaj" on 28th January, 2018. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for the submission of technical proposals is given as 08-02-2018, which is 3 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Terms & Conditions for E-Bidding:-

- The Bids shall be submitted electronically through E-Bidding on or before the fixed date /time.
- The bidder shall submit the bids with requisite documents through courier including 2% Bid Security of the estimated cost + stamp duty in the shape of call deposit (original) in sealed envelope before closing date and time.
- The bidders who quote their bids/rates more than 10% below the Engineers estimate shall also submit an additional security in sealed envelop through courier in the form of call deposit equal to 8% of the Estimated Cost. In case the bid is not accompanied by the additional security then bid shall be considered as non-responsive.
- Tenders shall be opened on advertised date and time in the presence of bidders or their representatives who may like to attend the session. In case of any unforeseen reasons, public holiday, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.
- The original and all copies of the bid shall be typed or written in indelible ink and shall be signed by a person or persons duly authorized to sign (Form B shall be attached if applicable). All pages of the bid/ tender documents shall be initialed and official seal be affixed by the person or persons signing the bid.
- The bid security shall be forfeited if a bidder withdraws his bid, within the validity period thereof or, in the case of a successful bidder, who repudiates the contract or fails to furnish performance security.
- All federal and provincial duties /stamp duty /taxes including sales tax will be recoverable as per directives of the government issued from time to time.
- Electronic bids will be valid for Ninety (90) days from the closing date of bids.
- Call Deposit of Scheduled Banks shall be acceptable. No Bank cheque or pay order shall be acceptable.
- If any document submitted along with bid documents found false /bogus the registration of the contractor/ firm shall stand cancelled/black listed.
- Any disfiguring cover writing, manipulation in the tender shall be liable to rejection.
- Only the first two figures after decimal of the rate will be considered for evaluation of the bid.
- Incomplete, conditional and bids without 2% of earnest money or without additional security (if applicable) shall be considered as non-responsive.
