This is with reference to TMA, Upper Dir's Tender Notice, published in daily "Express" on 27<sup>th</sup> January, 2018. It is observed that the advertisement is in violation of the KPPRA Rules 2014.


As per the advertisement, only the date and time for submission of tender is mentioned, whereas it should also include the date and time of opening of tenders that shall be on the same day. Therefore the advertisement is in a violation of KPPRA Rules 2014, Rule No.37 (6). Stated as under;

*37. Submission of bids and bid opening: — (6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

**Terms & Conditions.**

- (1) The Tender Form/BOQ Can be downloaded after publication in the newspapers by the Original Registered Contractors on the Local Council Board website (www.lgkp.gov.pk.)
- (2) The online Tender documents must accompanied with 2 % EM in the shape of original Call Deposit on the name of TMO, TMA Kalkot, Copies of CNIC, Enlistment, and Engineering Council Form H in case of Partnership and Authority letter for representation on behalf of the enlisted Contractor.
- (3) The Tender form and BOQ must be signed by the original Contractor
- (4) The Successful Contractor have to pay stamped duty along with contingency Charges, and all applicable provincial/ Federal Govt Taxes issued from time to time.
- (5) Only the above or below rates on MRS-2017 on the Engineers Estimate will be accepted. More than 10 % below rates should include 8 % Additional Security in shape of CDR in the Name of TMO TMA Kalkot
- (6) In case the bidder quotes more than 10% below, the estimated cost, and the bid is not accompanied by the additional security, then the bid shall be considered as non-responsive and the 2<sup>nd</sup> lowest bidder and so on will be considered accordingly.
- (7) The Contractor who will quote his rate more than 20% below, will have to submit rate analysis within 03 days, without issuing notice, otherwise his bid will be considered non-responsive.
- (8) The tender shall be processed according to "above/ below system" Based on MRS 2017.
- (9) Bid security of same or all the bidder will be retained by the Employer till approval of tender/bid validity period.
- (10) Original Tender documents must reach to TMA Kalkot in sealed envelope while same duplicate copy should also be sent to the office of Secretary Local Council Board Khyber Pakhtunkhwa Peshawar through Postal/currier service. No tender documents will be accepted through mail /fax/ by hand or unsealed envelopes. Responsibility of timely submission of documents will rest upon the Contractors, after due date and time no offer will be entertain for bidding
- (11) False/Bogus/Incomplete documentation should be rejected and their registration will be liable for blacklisting/cancellation and their securities deposits will be forfeited in favor of this TMA
- (12) This office is not bound to provide any machinery/ testing laboratory & the total cost on it will be borne by the contractor themselves.
- (13) Any bidder/ contractor who submitted tender form without call deposit, their case will be forwarded to high-ups for blacklisting.
- (14) The rates become equal between the contender's contractors the successful bidder will be decided through free toss.
- (15) Work order will be issued to the lowest bidder/ contractor subject to release of funds under above ADP Scheme 2017-18 for the finance department/ Govt of Khyber Pakhtunkhwa
