Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Chief Municipal Officer/ Municipal Officer Infrastructure, Municipal Committee, Dasu, District Kohistan's Quotation Notice for Purchase of Hydraulic Tractor Trolley and Blade.

Dear Sir,

This is with reference to Municipal Committee, District Kohistan's Quotation Notice published in daily "Aaj" on 29th June, 2016. It is observed that the advertisement is in violation of the KPKPRA Rules 2014.

1. It is mentioned that quotation must reached within 7 days of the publication of the advertisement, which is 7 days short and is violation of KPPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.


2. Also, quotation must reached within 7 days of the publication of the advertisement, whereas it should clearly include the last date and time of submission as well as opening of quotation that shall be on the same day. Therefore the advertisement is in a violation of KPPPRA Rules 2014, Rule No.37 (3) (6). Stated as under;

*37. Submission of bids and bid opening: — (3) The procuring entity shall issue the bidder with a receipt showing the date and time when the bid was received.
(6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.
