**Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Assistant Treasurer, Women University Mardan's Expression of Interest Notice for Provision of Services for Design and Detailed Supervision of Planning and Construction of New Campus.**

Dear Sir,

This is with reference to Women University Mardan's EOI Notice, published in daily "The News" on 28<sup>th</sup> May, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per the advertisement, "The University reserves the right to reject one or all proposals without assigning any reason". It is not complying with KPPPRA Rules 2014, Rule No.47 (1), which requires that reason should be communicated to bidders. Stated as under;

***47. Rejection of bids: - (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.***

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the EOI under the prescribed procedures or issue a corrigendum and extend date accordingly.
