Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, District Education Officer (Male), District Mansehra's Tender Notice for Purchase of Furniture.

Dear Sir,

This is with reference to District Education Officer (Male), District Mansehra's Tender Notice published in daily "Aaj" on 26th November, 2015. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

1. As per the advertisement, "the last date for submission of tender is on 17-12-015 while the opening of tender is kept on 18-12-2015". It is a violation of KPPRA Rules 2014, Page 18, 'Submission of bids' clause and according to the rule the last date for submission of bids as well as the public bid opening should be the same. Stated as under;

Submission of bids and bid opening: — (6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.

2. Also, "The procurement authority has the right to cancel one or all the bids at any stage without assigning any reason". However, it is violation to KPPRA Rules 2014, Page 21, Stated as under:

Rejection of bids:- (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Mis-procurement.— Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.

Terms and Conditions:-

1. Last date of submission of sealed tenders is 17-12-2015 upto 3:00 PM.
2. Tenders will be opened in the presence of Dealers/ Contractors/ Representative of Dealers at Office of the Deputy Commissioner Mansehra on 18-12-2015 at 12:00 PM.
3. Tenders form along with items required Performa/Rate List Performa is available at DEO (M) office during office hours on payment of Rs 500/- as Tender Form fee, the same is also available on PPRA website www.ppra.org.pk and E&SE Khyber Pakhtunkhwa Web site www.kpese.gov.pk.
4. Specification is mentioned in tender Documents.
5. Unsealed and incomplete Bid Documents will be rejected.
6. Tenders should consist of Income Tax clearance certificate for the year 2014-15 otherwise tender will be rejected.
7. 2% call Deposit will be obtained from the concerned dealer/contractor on the spot on acceptance of the bids.
8. There will be Two Envelop for tender Documents i.e. Technical Proposal & Financial Proposal.
9. If a dealer or his representative failed to present at the opening day of bids their tender will be considered as cancelled automatically.
10. Tempered/overwritten rates will not be accepted.
11. Supply will be completed within 30 days of issuance of the supply order.
12. The procurement authority has the right to cancel one or all the bids at any stage without assigning any reason and the dealers/ contractor cannot claim for any compensation of any nature whatsoever.
13. Payments will be made to the concerned dealers on completion of supply within stipulated period and after physical verification/inspection of the purchase committee.
14. After completion of inspection, supply should be made to the concerned schools on F.O.R basis.
