Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Director Works, University of Malakand, Chakdara Dir Lower's Tender Notice for Miscellaneous Works.

Dear Sir,

This is with reference to University of Malakand, Chakdara Dir Lower's Tender Notice, published in daily "Aaj" on 26th November, 2015. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, "it is mentioned that the tender forms will be issued from 02-12-15 till 11-12-15 and not till the closing date". It is violation to KPPRA Rules 2014, Page 17. Stated as under;

Bid solicitation documents. (5) Solicitation documents shall be made available to the bidders from the date of their issuance to the closing date on submission of required fee by the prospective bidder whether in person or, if so requested through an authorized request in writing. In case the request is made through courier, it shall accompany a bank draft in favor of the procuring entity including the cost of return delivery.

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned in KPPRA Rules 2014, page 22 stated as under; and with request to re-invoke the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Mis-procurement. – Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.
