Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Tehsil Municipal Officer/ Tehsil Nazim, Tehsil Municipal Administration, Dera Ismail Khan's Request for Proposal Notice for Construction of Shopping Plaza.

Dear Sir,

This is with reference to Tehsil Municipal Administration, D.I. Khan's RFP Notice published in daily "Express" on 24th October, 2015. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, it is mentioned that "RFP document/ TOR can be obtained on any working day at least 7 days before the closing date". However, the rule "Response Time" includes purchase of bidding documents for the bidder from the date of publishing of advertisement till the date of submission of bids;

Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the RFP under the prescribed procedures or issue a corrigendum and extend date accordingly.

Mis-procurement. – Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.
