Sub: Violation of Khyber Pakhtunkhwa Public Procurement Regulatory Authority Act
2012 Hospital Director, MTI, Lady Reading Hospital, Peshawar's Tender Notice for
Supply of Miscellaneous Items.

Dear Sir,

This is with reference to Lady Reading Hospital, Peshawar's Tender Notice, published in daily "Dawn" on 28th May, 2016. It is observed that the advertisement is in violation of KPK PPRA Act 2012 and KPPPRA Rules 2014.

As per the advertisement, Lady Reading Hospital, Peshawar has restricted the bidders to supply LED of Samsung brand only, and has not added "**or equivalent**" with it, which is not allowed under KPK PPRA Act 2012, Section No. 23 (4). Stated as under;

23. Bid Solicitation documents --- (4) Each procuring entity shall solicit bids based on performance or functional specifications and not on restrictive or proprietary specifications of a particular brand.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

TERMS AND CONDITIONS:-

- The rates approved will remain effective till 30/06/2017.
- Only typed tender on original prescribing letter pad, sealed & signed (Every Page) should be submitted, hand written tender would not be acceptable. The tenders must be according to hospital specification; alternate rates will not be acceptable.
- The tender must be submitted along with the call deposit as mentioned above; otherwise the tender will not be acceptable. The CDR must be from the Bank of Khyber, However, this condition will not be mandatory where the Bank of Khyber having no branch in reasonable distance.
- Sample of the quoted items should be produced by the bidder on the date of purchase committee meeting. In case of failure the bid/tender will not be considered.
- The bidder will be bound to ensure the supply within 30 days or as early as possible on receipt of order, otherwise the supply will be made on risk and cost of successful bidder.
- The Income Tax, stamp duty and Professional Tax or any other Government tax will be charged as per rules. However, this hospital is exempted from the General Sales Tax. (Only those firms will be honoured that are on Active Taxpayer's List of FBR).
- A Pre-Bid Meeting will be held on 10/05/2016 at 10:00 Am. The bidders are requested to thoroughly study the Standard Bidding Documents before the Pre-Bid meeting for any clarification of their queries during the said meeting.
- No conditional tender will be acceptable.
- The successful bidder will be bound to execute agreement on a stamp paper, with 1st order received.
- A detailed list of specification of required items can be obtained from the Purchase Cell of LRH during working hours (Saturday is not working day). The specification is also available on our web-site www.gov.lrh.com
- If the successful bidder supplies substandard items and not matching with specification issued from this office will be cancelled automatically.
- Tender giving company must attach the relevant documents along with their tender that should show that their company is Manufacturer, Importers and authorized dealers of the relevant items
- Income Tax, Professional tax and all other required documents must be attached with the tender.
- If the supply is not done within the period mentioned in the supply order, penalty @ 2% will be charged upto 15 days and beyond 15 days the penalty will be charged @ of 5%.
- The purchase committee has the right to accept or reject the tender partially or totally and at any stage, after communicating the reason for rejection.
- The competent Authority has the right to reject all bids under Rule 47 of the Khyber Pakhtunkhwa Public procurement Regulatory Authority (KPPRA) Procurement Rules 2014, assigning valid reasons.
