Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods and Services Rules 2014,
Section Officer (General), Higher Education Department, Peshawar's Tender Notice for Purchase of
Photostat Machine.

Dear Sir,

This is with reference to Higher Education Department, Peshawar's Tender Notice published in daily "Mashriq" on 2nd January, 2017. It is observed that advertisement is in violation of KPPRA Rules 2014.

1. As per the advertisement, no information regarding issuance of bidding documents is given for the bidders. Therefore, the advertisement is in a violation of KPPRA Rules 2014, Rule No.33 (5). Stated as under;

33. Bid solicitation documents. (5) Solicitation documents shall be made available to the bidders from the date of their issuance to the closing date on submission of required fee by the prospective bidder whether in person or, if so requested through an authorized request in writing. In case the request is made through courier, it shall accompany a bank draft in favor of the procuring entity including the cost of return delivery.


2. Also, "Committee reserves the right to reject tender, wholly or partially, without assigning any reason." Therefore, the advertisement is in a violation of KPPRA Rules 2014, Rule No.47 (1) that requires the reason to be communicated to the bidders. Stated as under;

47. Rejection of bids: - (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
