Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Director, Campus Police, Peshawar's Tender Notice for Repairing Works of Vehicles.

Dear Sir,

This is with reference to Campus Police, Peshawar's Tender Notice published in daily "Mashriq" on 30th October, 2015. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

1. As per the advertisement, "no information regarding issuance of bidding documents is given for the bidders". However, according to KPPRA Rules 2014, Page 17, 'Bid solicitation documents' clause, a set of tender document should be provided to the bidders. Stated as under;

***Bid solicitation documents.** (5) Solicitation documents shall be made available to the bidders from the date of their issuance to the closing date on submission of required fee by the prospective bidder whether in person or, if so requested through an authorized request in writing. In case the request is made through courier, it shall accompany a bank draft in favor of the procuring entity including the cost of return delivery.*

2. Also, "only the date of submission of bids is mentioned in the advertisement, without stating the time of submission and date & time of opening of bids that shall be on the same day". It is a violation of KPPRA Rules 2014, Page 18 & 19. Stated as under;


***Submission of bids and bid opening:** — (3) The procuring entity shall issue the bidder with a receipt showing the date and time when the bid was received
(6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.*

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned in KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

***Mis-procurement.**— Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.*
