Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Tehsil Nazim/ Tehsil Officer (I& S), Tehsil Municipal Administration (TMA), Dargai's Tender Notice for Miscellaneous Works.

Dear Sir,

This is with reference to TMA, Dargai's Tender Notice, published in daily "Aaj" on 2nd June, 2016. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per the advertisement, "the competent authority reserves the right to reject any or all the tenders without assigning any reason thereof". It is not complying with KPPPRA Rules 2014, Rule No.47 (1), which requires that reason should be communicated to bidders. Stated as under;

***47. Rejection of bids:** - (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

(2) The eligible contractors/firms are required to submit two separate envelopes i.e. one envelope containing technical information of the contractors/firm clearly marked as "Technical Bid" while the second envelopes containing bid price, clearly marked as "Financial Bid", shall be accompanied with earnest money/Bid security @ 2% of the Bid cost in favor of Tehsil Municipal Officer, Tehsil Municipal Administration, Dargai District Malakand from any scheduled bank of Pakistan (Accept Allied Bank Limited, The Bank of Punjab & Summit Bank Limited vide letter No.AO/LCB/8/2013 dated 27/11/2013). (3) Attested Photocopies of the requisite documents like Enlistment, Pakistan Engineering Council Registration and income tax certificate etc. must be attached with the application (original documents will be produced for confirmation on demand). (4) Bidding shall be carried out on "item rate basis". Wherein the Bidder are required to fill their own rates/amount in the blank columns against each item in the BOQ. In case no rate is quoted against any item, the same will be executed free of cost by the contractor, as per specification/drawing. Furthermore two decimal digits will be considered for evaluation.
