Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Deputy Director, Regulation O&M Reshun Power House, Chitral's Gallop Tender Notice for 11 KV Transmission Line of Reshun Power House Works.

Dear Sir,

This is with reference to Regulation O&M Reshun Power House, Chitral's Gallop Tender Notice, published in daily "Aaj" on 3rd May, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

Only the date and time of the opening of tender is mentioned in the advertisement, whereas it should also include the last date and time of submission of tender that shall be on the same day. Therefore the advertisement is in a violation of KPPRA Rules 2014, Rule No.37 (6). Stated as under;

37. Submission of bids and bid opening: — (6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
