Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Principal, Bacha Khan Medical College, Mardan's Tender Notice (2nd Time) for Printing Services.

Dear Sir,

This is with reference to Bacha Khan Medical College, Mardan's Tender Notice (2nd Time) Notice published in daily "Mashriq" on 1st November, 2015. It is observed that the advertisement is in violation of the KPPPRA Rules 2014.

1. As per advertisement, "no information regarding issuance of bidding documents is given for the bidders". However, according to KPPPRA Rules 2014, Page 17, 'Bid solicitation documents' clause, a set of tender document should be provided to the bidders. The Rule is stated as under;

***Bid solicitation documents.** (5) Solicitation documents shall be made available to the bidders from the date of their issuance to the closing date on submission of required fee by the prospective bidder whether in person or, if so requested through an authorized request in writing. In case the request is made through courier, it shall accompany a bank draft in favor of the procuring entity including the cost of return delivery.*

2. Also, that "The undersigned reserves the right to reject any quotation without assigning any reason". However, according to KPPPRA Rules 2014, Page 21, the 'Rejection of bids' Clause does not allow rejecting bids without assigning any reason and the reason of rejection should be communicated to the bidders". The Rule is stated as under;

***Rejection of bids:-** (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender on under the prescribed procedures or issue a corrigendum and extend date accordingly.

***Mis-procurement.**— Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.*
