This is with reference to Village Council Jagian, Kohalian, Abbottabad's Tender Notice, published in daily "Aaj" on 4th November, 2016. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per the advertisement, the last date for submission of forms is given as 24-11-2016 while the opening is kept on 25-11-2016. Therefore the advertisement is in violation of KPPRA Rules 2014, Rule No.37 (6). Stated as under;

37. Submission of bids and bid opening: — (6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Terms & Conditions:

- Tender form and BOQ can be downloaded by the original contractor available on LG&RDD website (www.lgkp.gov.pk) 2 days after the publishing of tender in Newspapers.
- 2.2% earnest money in the shape of call deposit, issued by scheduled Banks of KPK for each work in the name of Nazim VC Jagian Kohalian must be accompanied with the tender documents.
- The Contractors who offers/quotes the rate 10% above on the BOQ shall attached additional earnest money with the bid at the ratio of offered rates as "above" otherwise the bid shall be treated as rejected and 2nd earnest money already deposited will be forfeited and offer should be made to the 2nd lowest, 3rd lowest, as the case may be.
- The tender documents should be complete in all respect and incomplete documents will not be acceptable for consideration.
- The following document is required to be submitted with the application/tender form:
 - Enlistment copy and renewal with LG&RDD for the current year,
 - CNIC copy of the bidder.
 - Copy of registration and renewal of Pakistan Engineering Council for the current year, iv. National Income Certificate.
- Bidders found with bogus documents, their tenders will be rejected and their cases will also be forwarded to higher ups for black listing.
- The contractors/firms will have to start work immediately (within one week), after the issuance of work orders, otherwise their call deposits will be forfeited and they will not be allowed to participate in any tendering process.
- The procuring entity may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring entity shall upon request communicate to any contractor or consultant who submitted a bid or proposal, the ground for rejection of all bids or proposals as per KPPRA Rules.
- The cost estimate of the works is prepared on MRS-2016. Contractor should quote their rates as above/below percentage in figures as well as in words in the respective columns, and only the first two figures after decimal of the rates will be considered during evaluation of the bids. In case of blank column, the Contractor shall be bound to execute that particular item free of cost.
- Any cutting/overwriting on the BOQ will be liable to rejection of the tender and will be declared defective.
- Tenders/bids should reach the office of the concerned council as mentioned above through courier/registered post before the opening time. Responsibility of late delivery will not rest upon this office.
- The duplicate copy of sealed tender must be sent to concerned Assistant Director LG&RDD office for record purpose before the closing date and time of the tender.
- Other terms and conditions can be obtained from the Office during working hours and can be downloaded from the department's website.
- Any addition of amendment made in terms and conditions in the NTT advertised in the newspaper will be implemented as per KAPPRA rules.
