Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Executive Engineer, C&W Division, Mansehra's NIT Notice for Improvement/ Carpeting of Roads & Extension of District Bar.

Dear Sir,

This is with reference to Executive Engineer, C&W Division, Mansehra's NIT Notice, published in daily "Aaj" on 30th September, 2015. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, "the closing date & time of tenders is given, without stating date & time for opening of tenders that shall also be on the same day". It is a violation of KPPRA Rules 2014, Page 18 & 19. Stated as under;

*Submission of bids and bid opening: — (3) The procuring entity shall issue the bidder with a receipt showing the date and time when the bid was received
(6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.*

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the NIT under the prescribed procedures or issue a corrigendum and extend date accordingly.

Mis-procurement. — Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.
