Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, District Police Officer, Police Department, Kohat's Tender Notice for Vehicles on Rent.

Dear Sir,

This is with reference to Police Department, Kohat's Tender Notice published in daily "Mashriq" on 1<sup>st</sup> October, 2015. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

1. As per advertisement, "the last date for submission of tender is on 14-10-2015 while the opening of tender is kept on 15-10-2015". It is a violation of KPPRA Rules 2014, Page 18, 'Submission of bids' clause and according to the rule the last date for submission of bids as well as the public bid opening should be the same. Stated as under;

*Submission of bids and bid opening: — (6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.*

2. Also, it is stated that "The undersigned reserves the right to reject any one or all tenders without any reason". However, according to KPPRA Rules 2014, Page 21, the 'Rejection of bids' Clause does not allow rejecting bids without assigning any reason and the reason of rejection should be communicated to the bidders". Stated as under;

*Rejection of bids:- (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

*Mis-procurement.- Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.*
