**Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services
Rules 2014, Secretary/Nazim, Village Council Ward Kach, Hangu's E-Tender Notice for
Miscellaneous Works.**

Dear Sir,

This is with reference to Village Council Ward Kach, Hangu's E-Tender Notice, published in daily "Nawaiwaqt" on 4th October, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per advertisement, 15 days of response time is not given and the last date for the submission of tenders is given as 15-10-2017, which is 3 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

 8. The bids offered Below on MRS 2017/ non schedule items will deposit additional security as per Government Policy in the shape of call deposit. This guarantee will be discharged on the expiry of the defect liability period of the contracts.
 9. Incomplete / conditional bids shall not be accepted.
 10. The Contractor will offer there rats on above/below/At par on items rates of Bid Sheet will be considered in Bidding Competition.
 11. The work will be started immediately after issuing work order. In case of absence of the Contractor for non-starting of work the Contract will be cancelled and his security / Earnest money will be forfeited.
 12. All relevant taxes will be deducted from the Contractor bills.
