Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Director Food Department, Khyber Pakhtunkhwa, Peshawar's Tender Notice for Purchase/ Supply of 100 Kg Capacity Jute Bags.

Dear Sir,

This is with reference to Food Department, Peshawar's Tender Notice published in daily "The News" on 4<sup>th</sup> March, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, "Secretary Food/ Procuring Agency reserves the right to decrease or increase the quantity of stores to be purchased," whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However, the advertisement is in a violation of KPPRA Rules 2014, Rule No.10 (c) (i), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

*10. Alternate methods for procurement of goods.--- A procurement entity may use the following alternative methods for procurement of goods, namely:*

*(c) a procurement entity shall only engage in alternate method if the following conditions exist, namely:*


*(i) repeat orders within a period of six months:*

*Provided that it does not exceed fifteen percent of the original contract value;*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

### TENDER NOTICE FOR THE PURCHASE / SUPPLY OF 100 KG CAPACITY JUTE BAGS

Sealed tenders are invited from the manufacturers of jute bags in the name of Secretary Food/Procuring Agency, Government of the Khyber Pakhtunkhwa, Food Department, Haji Camp GT Road Peshawar City for the supply of 1,000,000 empty jute bags as per following specification:-

#### OTHER CONDITIONS.

- Participating firms should offer bid minimum 20% of the tendered quantity.
- The firm should be registered with the Sales Tax Department. Tenders submitted by the firm should be accompanied with the Sales Tax Registration Certificate from the Sales Tax Department, in case of international tenderer, Registration certificate in their respective country of origin be attached. The firm should also submit NTN Certificate with statement having the income tax paid.
- In case of manufacturer certificate should be attached to the document along with 5 years performance issued by a valid Organization/Department.
- All tenders should be supported/ attached with 2% earnest money of the total value of the offered quantity in shape of call deposit/Bank draft in favour of Secretary Food, Khyber Pakhtunkhwa /Procuring Agency. However, the earnest money will be refunded to the unsuccessful tenderers after placing order with the successful bidders. The successful bidders will sign an agreement within 7 days falling which the earnest money will be forfeited in favour of Government of Khyber Pakhtunkhwa and deposited 8% security amount of the total value in the name of Secretary Food Khyber Pakhtunkhwa which will be refunded in the production of no objection certificate from the concerned District Food Controllers.
- The Bags should bear wove/stenciled/printed mark as " FOOD DEPTT: Khyber Pakhtunkhwa 2015-16" alongwith initials or name of the millie and also bear one green longitudinal strip of one inch (1") each running through centre on both sides of the bags.
- The bags without Marka and strips as mentioned above will not be acceptable and if such bags are found in the bales, the same shall be replaced or payment for such bags shall not be made
- The payment of carriage/un-loading/stacking charges at consignee's end will be the responsibility of the manufacturers.
- Each page of the tender documents i.e. tender form will be signed by the tenderer duly stamped.
- Analysis report from any state owned Laboratory/Institute or any other nominated by the Senior Technical Officer will be acceptable. Besides physical testing will also be made by the Committee both of quality and quantity.
- Offer will be valid for 30 days from the date of opening of tender.
- Tenders may be submitted (in duplicate) on the prescribed form as per conditions of tender enquiry available from the Accounts Section of Food Department Khyber Pakhtunkhwa on cost of Rs.1000/- non refundable. Photo copy of the tender enquiry will also be acceptable.
- All tenders should be submitted in double envelop. In the first envelop specifications would be given whereas in the second envelop rates would be offered. If specifications are not in accordance with the specifications given by the Food Department, the offer will not be considered.
- The Local/International tenderers, they will quote their rates in Pakistan currency inclusive of all taxes levied by the Government.
- Manufactures will be responsible to arrange the supply of jute bags at any Provincial Reserve Centers of Khyber Pakhtunkhwa as per order of the Director Food.
- The contract as a whole should be governed by the terms and conditions as laid down in the Khyber Pakhtunkhwa Procurement Rules.
- The date of receipt of tender form will start from the date of publication of tender notice. Last date for submission of tender form will be **14.03.2016 at 04:00 P.M.** The tenderers who can not submit their tenders personally should submit their tenders through courier services or through registered post ensuring their receipt before the closing of tenders submission time. All the bids should be submitted alongwith five samples of bags.
- Tenders will be opened in the Committee Room of Food Department, in the presence of Tender Opening Committee and authorized representatives of the bidders on **15.03.2016 at 12:00 P.M.** if the tender not held on the same date then it will be held on second time on **22.03.2016 at 12:00 P.M.** and third time on **30.03.2016 at 12:00 P.M.**
- Secretary Food/Procuring Agency reserves the right to reject the tenders in part or in full on basis of cogent ground reasons and to decrease or increase the quantity of stores to be purchased.
