Dear Sir,

This is with reference to Elementary and Secondary Education Department, Peshawar's Tender Notice published in daily "Aaj" on 3rd November, 2015. It is observed that the advertisement is in violation of the Khyber Pakhtunkhwa Public Procurement Regulatory Authority Act 2012.

As per the advertisement the undersigned has restricted the bidders to supply Toyota Hilux Pick up/ Vigo, Toyota Corolla and Suzuki Cultus only, and has not added "or equivalent" with it, which is not allowed under KPK PPRA Act 2012 Section No. 23 (4). Stated as under;

23. Bid Solicitation documents --- (4) Each procuring entity shall solicit bids based on performance or functional specifications and not on restrictive or proprietary specifications of a particular brand.

The above information is forwarded for the purpose of avoiding mis-procurement, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
