Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Director, Directorate of Archeology and Museums, Peshawar's Tender Notices for Supply of Material & Different Works.

Dear Sir,

This is with reference to Directorate of Archeology and Museums, Peshawar's Tender Notice published in daily "Mashriq" on 3<sup>rd</sup> November, 2015. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per the advertisement, "it is mentioned that the tender forms will be issued from 26-11-15, that is, two days prior to the submission date". It is violation to KPPPRA Rules 2014, Page 17. Stated as under;

***Bid solicitation documents.** (5) Solicitation documents shall be made available to the bidders from the date of their issuance to the closing date on submission of required fee by the prospective bidder whether in person or, if so requested through an authorized request in writing. In case the request is made through courier, it shall accompany a bank draft in favor of the procuring entity including the cost of return delivery.*


National Accountability Bureau (NAB), has also directed vide its letter No 5-2 (75) Pre/ A & P/ NABHQ/ 2013 dated 8<sup>th</sup> January (Copy enclosed), all procuring agencies should make available the bidding or prequalification documents and other related communication in downloaded format, for any interested bidder or party, at their website to use these documents for submitting bid(s) with admissible tender fee.

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned in KPPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

***Mis-procurement.**— Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.*

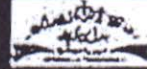
