

It is stated for your kind information that all 36 Bidders (including Non-responsive, Not-qualified and qualified) were invited to appear for Financial Bid opening on 26-10-2016. Non-responsive bidders due to Non-submission of primary documentation and Not-qualified due to low merit points were returned Financial Bids un-opened and also clarified the Technical Evaluation report of the Committee before them. Ms. Friends Traders (Complainant) was also informed/ participated vide this office letter # F.3-1/2016-PIU/GKMCS dated 24-10-2016 in the due process of the said procurement. The firm has also been replied vide letter F.No.3-1/2016-PIU/GKMCS dated 02-11-2016 (Copy enclosed).

Furthermore, it is submitted that GKMC Swabi is a new establishment in the cluster of Public Sector Medical Colleges of the province under the auspices of Health Department declared in the year 2013 (Copy enclosed). The main deficiency at present, is the procurement of Bio-Medical equipment, instruments and General items for the establishment of the Institute. Thus Re-tendering process in view of such minute issue will further delay the process of recognition/ starting of the College.

Dear Sir,

Transparency International Pakistan has received a complaint from M/s Friends Traders against Tender Notice of Gajju Khan Medical College, Swabi for 'Procurement of Medical Equipment, Instruments and General Items (IFB) Procurement and Installation of Medical Equipment, Instruments and General Items under (NCB)' (Copy Enclosed).

The complainant has made following allegations;

1. That the tender notice of Gajju Khan Medical College, Swabi appeared in the JAHAD newspaper on 22-06-2016 for Procurement of Medical Equipment, Instruments and General Items through single stage two envelop bidding procedure.
2. That evaluation of technical bid was not shared either via email or report up till 26-10-2016, i.e., on the financial opening date. It is in a violation of Chapter V of Miscellaneous Provisions of KPPRA Rules 2014, Rule No.45. Stated as under;

*45. Announcement of evaluation reports.—Procuring entities shall announce the results of technical bid evaluation in the form of a report before opening of the financial bids, to all bidders. The procuring entity shall also announce the final results of a bid evaluation giving justification for acceptance or rejection of bids at least ten days prior to the award of a contract and place the same on its and Authority website.*

3. That the financial opening has taken place on 26-10-2016 in the presence of all bidders without technical points; therefore complainant was not given the opportunity to clarify their position technically.

Project Director, Gajju Khan Medical College Swabi is requested to kindly examine the complaint and if found genuine cancel and re-tender the as per KPPRA Rules 2014.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.
