Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, All Secretary/ Nazimeens Concerned, Village Council Babi, Tehsil Pabbi, District Nowshera's E-Tender Notice for Repair/ Construction and General Cleanliness Works.

Dear Sir,

This is with reference to Village Council Babi, Tehsil Pabbi, District Nowshera's E-Tender Notice, published in daily "Aaj" on 6th October, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per advertisement, 15 days of response time is not given and the last date for the submission/ opening of bids is on 17-10-2017, which is 3 days short and is violation of KPPPRA Rules 2014, Rule No.34 (1). Stated as under:

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

The 8% additional security of the estimated cost shall be attached with the bids offered below 10% with the form, failing to do so will lead to the cancellation of the form. (6). Cutting/ Overwriting in the BOQ/ Contract will be termed as defective. (7). Work order will be issued to the contractor subject to the availability of funds. (8).
