Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, District Police Officer, Chitral's Quotation Notice for Repairing Works of Government Vehicles.

Dear Sir,

This is with reference to District Police Officer, Chitral's Quotation Tender Notice, published in daily "The Nation" on 6th December, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

1. As per advertisement, 15 days of response time is not given and the last date for the submission of tenders is on 04-12-2017, which is incorrect as the date of publishing advertisement of quotation is 06-12-2017 and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

2. Also, the tender submission date is given as 04-12-2017 while the opening dates on 14-12-2017. Therefore, the advertisement is in violation of KPPRA Rules 2014, Rule No.37 (6). Stated as under;

37. Submission of bids and bid opening: — (6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.
