Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Deputy Commissioner, Malakand's Tender Notice for Hiring of Vehicles.

Dear Sir,

This is with reference to Deputy Commissioner, Malakand's Tender Notice for Hiring of Vehicles, published in daily "Mashriq" on 4th February, 2016. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per the advertisement, no information regarding issuance of bidding documents is given for the bidders. Therefore, the advertisement is in a violation of KPPRA Rules 2014, Rule No.33 (5). Stated as under;

33. Bid solicitation documents. (5) Solicitation documents shall be made available to the bidders from the date of their issuance to the closing date on submission of required fee by the prospective bidder whether in person or, if so requested through an authorized request in writing. In case the request is made through courier, it shall accompany a bank draft in favor of the procuring entity including the cost of return delivery.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- v Vehicles will be used in District Malakand.

- vii Police Clearance Certificate of Drivers must be provided.
- viii P.O.L will be provided by the Project/Deputy Commissioner Office.
- ix The vehicles will be at the disposal of Deputy Commissioner Office till completion of the agreement i.e. 30/06/2016 and onward if agreement extended, with the firm/bidder,
- x Sealed tenders should be submitted to Deputy Commissioner Malakand office at Batkhela before 29/02/2016 12:00PM. Tenders will be opened on same day at 12:30PM in the office of the Deputy Commissioner, Malakand in presence of bidders.
- xi C.D.R for amount of Rs. 22000/- should be attached with tender.
- xii The successful bidder should have present the vehicles before committee within three days after opening of bids.
- xiii In case of non-accepting of vehicles of the 1st lowest bidder, vehicles of the 2nd lowest bidder will be considered and so on.
- xiv All taxes would be deducted according to rules.
- xv Procuring entity reserve the right to reject the bids prior to acceptance of bids in light of Rule 47 of KPPRA Rules.
