Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, District Health Officer, Peshawar's Tender Notice for Procurement of Bio-Medical Equipment & General Items Supplies.

Dear Sir,

This is with reference to District Health Office, Peshawar's Tender Notice published in daily "Aaj" on 5th October, 2015. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per advertisement, it is stated that "Quantity of the items can be increased/ decreased." Any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However, according to KPPRA Rules 2014, Page 6 & 7, repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

Alternate methods for procurement of goods.--- A procurement entity may use the following alternative methods for procurement of goods, namely:

(c) a procurement entity shall only engage in alternate method if the following conditions exist, namely:

(i) repeat orders within a period of six months:


Provided that it does not exceed fifteen percent of the original contract value;

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Mis-procurement.--- Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.

Tender Notice

Procurement of Bio*Medical Equipments & General Items Supplies.

1. The District Health Officer, Peshawar invites sealed bids from the eligible bidders for supply of bio-medical equipments, hospital supplies and general items to meet the requirement of District Peshawar under different ADP Schemes for current financial year 2015-16 under Single Stage – Two envelopes bidding method, comprise a single package containing two separate envelopes. Each envelope shall contain separately technical proposal & financial proposal clearly marked as financial proposal & technical proposal in bold & legible letters. Detailed specifications and quantities of equipments etc are included in the Standard Bidding Documents under rules 6(b) of KPPRA 2014.
2. Interested eligible, pre-qualified bidders may obtain a complete set of original Bidding Documents at the cost of Rs. 1000/- printing, stationary charges (non-refundable) on their written request from the office of the undersigned on any working day during office hours.
3. A pre-bidding meeting shall be held at the office of the undersigned on 16/10/2015 at 10:00 AM. The bidders are requested to thoroughly study the Standard Bidding Documents before the pre-bidding meeting for any clarification of their queries during the said meeting.
4. Bids must be delivered at the address given below, on 27/10/2015 at or before 11:00 hours and shall be opened on same day at 11:30 hours in the presence of bidders or their authorized representatives.
5. Financial bids must be accompanied with a bid Security/ Earnest Money which is 2% of the total bid value for registered firms with Directorate General Health Services Khyber Pakhtunkhwa in the form of a Pay Order/ Bank Draft/ Deposit at Call in favor of District Health Officer Peshawar.
6. Technical bids must be accompanied with an affidavit with the effect that 2% earnest money not showing the amount, call deposit/bank draft are attached with the financial proposal, otherwise the technical proposal shall be considered non-responsive.
7. The bidders are requested to give their best and final price if the quoted equipments etc as per the specifications of the Standard Bidding Documents as no negotiations on the price are allowed. The bid shall be valid upto four months (120 days) from the date of opening of bids. Quantity of items can be increased/decreased.
8. The procurement entity may reject all bids or proposals at any time prior to the acceptance of a bid or proposals. The procuring entity shall upon request communicate to any contractor or supplier who submitted a bid or proposal, the grounds for rejection of all bids or proposals under rules 47 of KPPRA 2014.
9. The highly technical equipments should be guaranteed/warranty as per rules.
10. The suppliers will be responsible for the training of end user/electro medical technical staff on the equipments. Also the supplier will provide technical manual/circuit diagram of the purchased equipments.
