Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Assistant Engineer, LG&RDD, Peshawar's E-Tender Notice for Construction, Repair, Installation & Supply/ Fixing Works.

Dear Sir,

This is with reference to LG&RDD, Peshawar's E-Tender Notice, published in daily "Aaj" on 7th March, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, 15 days of response time is not given and the last date for the submission of bids is on 17-03-2016, which is 4 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the E-Tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

TERMS & CONDITIONS:

- 1) Last date for submission of tender documents is 17th March 2016 (12:00 pm), while opening of tender will be at the same day at 2:00 pm. The completion period will be as per work order.
- 2) - All the tenders/bidding shall be done on "Items Rate System". Bidders should fill their own rate in the blank column against each item and total amount. If there is any discrepancy between the unit rate and total amount, obtained by multiplying the unit rate and quantity, the unit rate will prevail and the total amount shall be corrected. If the bidder does not accept the -corrected amount of bid, his bid will be rejected and his bid security will be forfeited. If rate against any item was found blank, the same will have to be executed by the contractor at his own cost as per specifications. Furthermore, first two decimal digits will be considered for evaluation.
- 3) The following shall be attached with the bids: (i) Enlistment and Renewal Copy in LGE & RDD Department for the Year 2015-16 (ii) Photocopy of CNIC (iii) Power of Attorney (if applicable)
- 4) Cost of tender form/documents mentioned in the website is payable through Demand Draft and Pay Order (Non-refundable) in the name of Assistant Director, LG & RDD, Peshawar, A/C No. 8347-0, NBP, Charsadda Road Branch Opposite Eid Gah Peshawar.
- 5) For the "Repair of Transformers works at any location: the following instructions to be followed by a contractor registered with WAPDA. (1) The Executing Agency will inform the concerned Local Sub Divisional Officer of PESCO before the dismantling of the transformers. (2) The Executing Agency shall ensure the repair work through M&T Lab of PESCO so as to identify & verify the damages in the transformers. (3) Accordingly the damages/repair work identified by the M&T Lab of PESCO should be carried out from the authorized/approved workshops of PESCO. (4) The repaired transformer should be re-checked from the M&T Lab before installation by the Executing Agency. (5) The claims/bills of the repair work should be verified from the Local Sub Divisional Officer of PESCO before submitting to the Executing Agency.
- 6) The 2% Earnest Money is mentioned against each work, shall be received in the shape of Call Deposit from scheduled bank in the name of Assistant Director, LG & RDD, Peshawar, which shall accompany with the tender documents along with stamp duty.
- 7) The contractors quoting rates below of the estimated cost shall deposit additional security in the shape of Call Deposit in the name of Assistant Director, LG & RDD Peshawar within three days of the opening of the bids. In case of failure of depositing the additional security by due date, the 2% Earnest Money already deposited with the tender documents will be forfeited in favor of Government and their lowest bidder (& so on) will be considered for bid. These call deposits will be discharged on the expiry of the defect liability period of the project.
- 8) Tender documents of bidders if found with bogus/false documents will be rejected and their registration shall stand cancelled/blacklisted in addition of forfeiture of earnest money.
- 9) Incomplete bids or without 2% earnest money shall not be accepted.
- 10) Cutting/Over writing in the BOQ/Contract will be termed as defective.
- 11) The limits for below rates shall be followed as per Government rules.
- 12) The original and all copies of the bid shall be typed or written in indelible ink and shall be signed by a person or persons duly authorized to sign. All pages of the bid/tender documents shall be initialed and official seal be affixed by the person or persons signing the bid.
- 13) Original tender documents in sealed envelope should reach to Assistant Director, LG & RDD Peshawar while copy of the same documents should reach to the Director General, LGE & RDD Peshawar KPK through courier. No tenders are acceptable through Fax/by hand.
- 14) Sealed bids sent through registered mail/couriers service should reach upto the specified time and date, and will be opened in presence of bidders/representatives. In case of tender not opened on the above mentioned date, because of any unforeseen reason, the tender shall be opened on the next working date at same place and time.
- 15) Tender documents / BOQ can be downloaded from the date of publication in the newspaper till one day prior to opening of tender from Local Government Elections & Rural Development Department website, www.lgkpp.gov.pk.
