Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Medical Superintendent, Sifwat Ghayur Shaheed Memorial Hospital, Peshawar's Tender Notice for Purchase of Zakat Medicines.

Dear Sir,

This is with reference to Sifwat Ghayur Shaheed Memorial Hospital, Peshawar's Tender Notice, published in daily "Mashriq" on 7th March, 2016. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per the advertisement, no information regarding issuance of bidding documents is given for the bidders. Therefore, the advertisement is in a violation of KPPRA Rules 2014, Rule No.33 (5). Stated as under;

33. Bid solicitation documents. (5) Solicitation documents shall be made available to the bidders from the date of their issuance to the closing date on submission of required fee by the prospective bidder whether in person or, if so requested through an authorized request in writing. In case the request is made through courier, it shall accompany a bank draft in favor of the procuring entity including the cost of return delivery.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- ii Call deposit of Rs. 20000/- must be attached with the quotation in the name of "Medical Superintendent Sifat Ghayur Shaheed Memorial Hospital Peshawar". Call deposits will be verified before preparing of the comparative statement. In case of bogus call deposit, action will be taken against the firm.
- iii The tender will be valid upto 30/06/2016.
- iv Deduction of Sales Tax and Income Tax will be made as per government rules and regulations.
- v Income Tax certificate, Professional Tax certificate, NTN and Sales Tax certificate should be attached.
- vi Selected party will be bound to supply the medicines round the clock in the best interest of patients.
- vii Substitute or substandard medicines will not be acceptable.
- viii The selection will be made on the highest discount rate only.
- ix "The competent authority has the right to reject all bids under Rule 47 of the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA), Procurement Rules 2014 by assigning reasons".
