Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Tehsil Nazim/TMO, Tehsil Municipal Administration (TMA), Alpuri, District Shangla's Tender Notice for Repair and Pavement Works.

Dear Sir,

This is with reference to TMA, Alpuri, District Shangla's Tender Notice, published in daily "Aaj" on 7th March, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.


As per the advertisement, 15 days of response time is not given and the last date for the submission of bids is on 17-03-2016, which is 4 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Tender document/BOQ can be downloaded up to one day prior to the last date of submission on tender form Local Council Board Department web site at the address www.lcb.gov.pk. Interested contractors/firms are instructed to obtain user name and password from Chief Engineer (South) Local Council Board Department Khyber Pakhtunkhwa for downloading of tender form and BOQ from the web site.
- Cost of Tender form /documents are mentioned above payable through demand draft and pay order (non-refundable) in the name of Tehsil Municipal Officer TMA Alpuri account No. PLS1616-8 National Bank of Pakistan Alpuri Branch Code No. 1934 (if applicable)
- 2% (Two Percent) earnest money & Stamp duty mentioned above must be accompanied with the tender document in the shape of call deposits in the name of Tehsil Municipal Officer TMA Alpuri from scheduled Bank (Accept Allied Bank Limited, the Bank of Punjab & Summit Bank Limited vide letter No. AQ/LCB/8/2013 dated 27/11/2013). Copies of the requisite documents like enlistment/renewal of Local Government & Rural Development Department (LCB) Khyber Pakhtunkhwa, Income Tax certificate, CNIC and Registration of Pakistan Engineering Council etc. must be attached with the tender documents in separate envelop.
- The tender documents must be signed by an authorized person of the firm /Contractor.
- If the bidders quoted below rate on BOQ/Engineer's Estimate the contractor will have to deposit Additional security equal to the below amount in the shape of Call Deposit in addition to 2% earnest money, otherwise they will be kept out of tender process and their Call Deposit (2% Earnest Money) will be forfeited.

Any delay in delivery of tender documents will be responsibility of the contractors.
- The bid documents received through fax or by hand will not be acceptable.
- The Contractor quoting their rate on "above/below" basis in BOQ/Contract will term as defective. Item wise rate will be accepted.
- In Case bids become tie the award of contract shall be decided through a free toss which shall be final.
- The bidder are at liberty to seek any clarification or further information from the office of the undersigned if desire.
- All federal and provincial duties/stamp duty/taxes including Sales tax will be receivable as per directives of the government issued from time to time.
- If any documents submitted along with bid documents found false/bogus the registration of the contractor/firm shall be cancelled / black listed.
