Mechanical Engineer, FDC Saw Mill & Workshop Unit, Mansehra's Tender Notice for Procurement of
Material/ Equipment.

Dear Sir,

This is with reference to FDC Saw Mill & Workshop Unit, Mansehra's Tender Notice published in daily "Aaj" on 4th October, 2015. It is observed that the advertisement is in violation of the KPPPRA Rules 2014.

As per advertisement, it is stated that "20 % of the total value of the tender as earnest money must be accompanied with the tender form". It is a violation of KPPPRA Rules 2014, Page 13. Stated as under;

Bid security.--(1) The procuring entity may require the bidders to furnish bid security of two per cent in case of procurement of works, if required.

(2) In cases, where procurement is of complex nature, bid security up to 5 percent can be applied.

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

***Mis-procurement.**— Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.*
