**GENERAL TERMS AND CONDITIONS :-** (1) Submission of Bank guarantee for the bid amount is mandatory. (2) The tender must accompany earnest money equal to 2% of the total value of the bid in the form of Call Deposit / Bank Draft (refundable) drawn in favour of Director General, Provincial Disaster Management Authority, Khyber Pakhtunkhwa, Peshawar. (3) The successful bidders shall have to abide by rules, procedures and instructions of the Provincial Government issued from time to time. (4) Bid with multiple options shall be rejected on the spot. (5) Warranty must be as per the tender specifications and should be verifiable from the manufacturer. (6) The vendor will provide an undertaking to supply the items, preferably, ex-stock or within the agreed timeline from the date the Supply Order is issued. Partial deliveries will not be accepted. (7) Prices must be valid for a minimum of 90 days from the date of bid opening. (8) Bids to be submitted in Pak Rupees Only, inclusive of all taxes. (9) No advance payment will be made. (10) Deduction of all government taxes will be mandatory as per rules. (11) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency upon request communicate to any supplier or contractor who submitted a bid or proposal the ground for its rejection of all bids or proposals, but is not required to justify those grounds as per Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014. (12) Attested/certified copy of the ISO - 9001 certificate required for items must be attached with the bid. (13) Bids without sample shall not be entertained. (14) The Competent Authority can reduce or increase the total quantity provided that repeat order within a period of six months shall not exceed 15% of the original contract value. (15) Bids with incomplete documents, received after the given deadline, offer for less than the given number of items, demand draft less than 2% percent of the total offered bid cost and not fulfilling the specification mentioned in the tender will be rejected. **CORRIGENDUM**

The general terms and conditions published in Daily 'NEWS' dated 29.08.2015 and Daily Aaj dated 31.08.2015 vide at S. No. 1 may kindly be read as under:-

1. Successful contractors may submit performance guarantee in the shape of irrevocable bank guarantee upto 10 percent of the bid value if the procurement entity deems fit. However, bid security of two percent may be released to the successful bidder.
