Sub: Complaint against Karachi Port Trust (KPT).

Dear Sir,

Transparency International Pakistan has received a complaint against Karachi Port Trust (KPT), from M/s Kamran Enterprises (Copy Enclosed).


The complainant has made following allegations;

1. That the officers of GM (CW) KPT, gave tenders to their favored contractors, mainly to M/s Pirbhoy & Sons and Patel Const. Co against bribe (cash payment).
2. That the tenders are not issued to other contractors even on request.
3. That all 'Emergency' tenders are awarded only to M/s Pirbhoy & Sons on special rates.
4. That the practice is of favoring, M/s Pirbhoy & Sons is going on for many years.

The Chairman, Karachi Port Trust (KPT) is requested to kindly examine the complaint and if the allegations are found correct kindly take up the case within 7 days and take necessary action against all those officers involved in corrupt practices.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

Paver Blocks M.I yard west wharf Phase IX (25 Millions) کا کام دیا ہے۔ یہ سب کام (رشوت) Cash payment کی صورت میں فروخت کیے ہیں۔ اور contractors کو درخواست دینے کے باوجود Tender issue نہیں کیا گیا جس پر میں نے شدید اعتراض اور احتجاج کیا ہے۔ KPT کے کوئی بھی Emergency Works ہو تو صرف اور صرف Pirbhoy & Sons سے کام کروایا جاتا ہے۔ کنڈر اور Contractors سے کام نہیں کروایا جاتا۔ Pirbhoy & Sons کو مخصوص طریقے سے نوازا جا رہا ہے اسکو من پسند Rate بھی دیئے جا رہے ہیں۔ حالانکہ Emergency Works کیلئے Gallop Tenders کئے جاتے ہیں لیکن ایسا نہیں ہو رہا ہے، جناب عالی آپ کے ادارے میں منظم طریقے سے Corruption ہو رہی ہے اسکا سدباب کیا جائے۔
