The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 56, and with request to re-invite the tender under the prescribed procedures.

- (vii) List of personnel with qualifications in permanent employment of the firms / consortium / joint venture, for the last one year in the related fields.
- (viii) Total personnel strength for the last one year.



Tenders must be delivered in the office of Deputy Managing Director (RRG), 1st Floor, Block-A, 9th Mile Office, Shahr-e-Faisal, Karachi before 12:00 noon on Wednesday, the 30th of November 2011 in the presence of Tender Opening Committee appointed by KW&SB and will be opened on the same day at 12:30 pm, by the Tender Opening Committee in presence of the Tenderers, who choose to attend the opening of bids.
