REGULATORY AUTHORITY IN SUBMISSION OF BIDS  
UNDER NIT NO.PD/MKKRP/05 DT.24/09/2010**

Reference: Your office letter No.A/1056/202/1 Dt.1/12/2010

With reference to your letter cited above it is clarified that this office has not committed any violation in tendering process called under NIT No.PD/MKKRP/05 Dt.24-09-2010.

1. The extension in dates for receipt & opening were made due to proposed 50% cut on Sindh ADP 2010-2011. Before opening of tenders a letter received from LGD vide no.LG/507/Misc/56/2010 Dated.11-10-2010 (copy enclosed) in which it was suggested to this office to prepare 50% cut proposals on all the projects. As soon as it was decided by the Govt. that the funds are not curtailed from Special Packages accordingly this office processed & tenders opened on 10-11-2010.

2. The extension in date of receipt & opening of tenders were made through widely publicity by means of Notice Board as well as print media. Therefore the allegations regarding to award the works to favourite contractors is vehemently denied.

3. About 186 contractors have participated in the Tenders of 46 works which is sufficient proof for transparency & healthy competition.

4. As far as the allegations leveled by M/s.Haji Abdul Baqi & Bros. M/s.Muhammad Haleem Mandokhail & M/s.Sindh Pipe Industries in their applications is concerned it is stated that the said Contractors have attended this office on 07-12-2010 and got satisfied with the reasons of extension in tenders. Since they did not participate in the competition and got ~~returned~~ refunded their call deposits.
