The Advisor Transparency International Pakistan, Syed Adil Gillani vide above mentioned letter addressed to undersigned, has forwarded the Minutes of the Meeting held on 09th October 2015 which was also attended by your good self, wherein he has pointed about his observation regarding the infirmities in the evaluation of bids, as reflected in para 9/N of the Minutes of the Meeting, vide letter No. DD(E-II)K-375(KWSB)/14-15/SPPRA/8967 dated: 18th December 2015 issued by SPPRA (copy enclosed) wherein Advisor TIP clearly recommended that the tender for "Supply & Fixing of Boundary Pillars and Walls" under K-IV Project, be discharged and re-invited.

Whereas the SPPRA, being the regulatory authority on public procurements in Sindh, did not suggest or recommend KW&SB, the further course of action in this regard.

It is therefore requested that clear position of SPPRA on the instant issue shall be communicated to KW&SB, in the light of serious observation shown by Advisor Transparency International Pakistan (TIP) Syed Adil Gillani, regarding the tender as mentioned above, in accordance to SPPRA-2010 Rules and any subsequent amendment made in such cases.
