Sub: Violation of Public Procurement Rules 2004, Section Officer (G&P), Interior Division, Ministry of Interior, Islamabad's Tender Notice for Supply of Branded IT Equipment/ Devices/ and Licensed Software.

Dear Sir,

This is with reference to Ministry of Interior, Islamabad's Tender Notice published in daily "The News" on 28th October, 2017. It is observed that the advertisement is in violation of the PPRA Rules 2004.


As per advertisement, 15 days of response time is not given and the last date for submission/ opening of tender is on 08-11-2017, which is 3 days short. It is a violation of PPRA Rules 2004, Rule No.13 (1). Stated as under;

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

2. Tender documents having detailed specifications alongwith Terms & Conditions can be obtained from the office of the SO (G&P), Room 604, 6th Floor, Block "R" Pak. Sectt. Those documents are required to be signed, stamped and attached with the bidding documents of the bidding firm.
3. Single stage-two envelope procedure: The bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the technical proposal and the financial proposal. The envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion.
4. The Technical Proposals and Financial Proposals will be submitted according to the given pattern as specified in the documents of Terms and Conditions.
5. Quotations for different products will be mentioned on separate pages. The name of the quoted product should be displayed clearly on the page.
6. Only those firms who qualify technical evaluation will be allowed to be considered in financial evaluation.
7. Delivery will be made within 6 weeks after issuance of purchase order.
8. All bidders must submit pay order @5% of the total bid value as earnest money in favour of Interior Division. The earnest money of successful bidder will be returned after expiry of warranty period.
9. Deadline for the submission of the bids is 8th November, 2017 and those should reach before 02:30 p.m. on the given date. Tenders/bids will be opened on the same day at or after 3:00 p.m. in the presence of bidders / representatives.
10. This Division reserves the right to accept or reject any or all tenders in the light of PPRA Rules 2004.
