**Sub: Violation of Public Procurement Rules 2004, Deputy Director, Poultry Production,
Gilgit Baltistan's Tender Notice for Purchase of Various Items.**

Dear Sir,

This is with reference to Poultry Production, Gilgit Baltistan's Tender Notice, published in daily "The News" on 31st Aug, 2018. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per terms and condition No. 11 in the advertisement, "Quantity of items can be increased or decreased according to budgetary position". Any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However according to PPRA Rules 2004, Rule No. 42 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under:

***42. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works, namely:-
(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:
(iv) repeat orders not exceeding fifteen per cent of the original procurement;***

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Terms & Conditions:-

- The tender rates would be considered valid for the F.Y 2018-19 upto 30-06-2019.
- The rate of each items should be quoted on the basis of F.O.R District Head quarter Gilgit
- Incomplete bids where details with complete specification/strength/manufacturer etc if not mentioned, will not be considered & will be rejected.
- Delivery time will be maximum three (03) weeks (other then animals)from the date of issue of supply order. In case of failure to complete the supplies in the stipulated time, total earnest money will be confiscated in favor of the state & Supplier will be black listed.
- Rate will be decided for individual items bid basis. (other then vehicle parts)
- 2.5% of the bid value in the form of call deposit issued by a scheduled bank may be deposited in favor of the Deputy Director, Poultry Production, Gilgit-Baltistan along with the tender.
- Supply orders will be subject to release of funds and according to the budgetary position.
- The list can be obtained from the office of undersigned during any working day and the tenderers must quote over the rates of items/list issued by the office and if the items out of list quoted will not be considered.
- Income tax would be recovered from the supplier as per govt. rules.
- The chairman of relevant tender committee reserves the rights to accept or reject in part or whole of tender without explaining reasons to this effect.
- Quantity of items can be increased or decreased according to budgetary position.
- Bill warranties will be responsibility of the supplier.
- The black listed firms/suppliers will not be allowed to contest in the tender.
- Separate envelopes & Call deposits must be provided for each component.
- Conditional tenders will not be accepted.
- In case of repair of vehicle the contractor must have its own setup(workshop) & experience in relevant field in city Gilgit (for vehicle, bid will be on lot basis)
