This is with reference Police Department, Mirpur Region's Tender Notice, published in daily "Khabrain" on 29th July, 2018. It is observed, the advertisement is in violation of the AJK PPRA Rules 2017.

As per advertisement, "Office of DIGP office reserves the right to cancel any or all tenders without assigning any reason", which is violation of AJK PPRA Rules 2017, Rule 33 (1). Stated as under;

33. Rejection of Bids.-(1) The Procuring Agency may reject all Bids or proposals at any time prior to the acceptance of a Bid or proposal. The Procuring Agency shall upon request communicate to any Supplier or Contractor who submitted a Bid or proposal, the grounds for its rejection of all Bids or proposals, but is not required to justify those grounds.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
