Transparency International Pakistan appreciates that the minister for full transparency/smooth functioning of the ministry has made Syed Adil Gilani Adviser to the Minister Ports & Shipping vide his letter No 1(1)/Min(P&S)/2013 dated 1-11-2013.

I have been directed by the Chairman to inform the Minister that according to the governance policies of TI-Pakistan, no trustee or adviser is allowed to take any assignment such as adviser to the minister, or ministry. Therefore the offer for making Syed Adil Gilani Adviser to the Minister Ports & Shipping may please be cancelled.

However, in case the minister intends to have zero tolerance for corruption in his ministry, TI Pakistan is enclosing an MoU which may be signed with TI Pakistan. MOUs have been signed by a number of Public and Private Bodies with TI Pakistan under which they avail our expertise for transparency in their organization.

This letter is being issued with consent of Syed Adil Gilani, Adviser TI-Pakistan.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

Memorandum of Understanding.

This Memorandum of Understanding (MOU) is signed on ___ Day of December , 2013 between Ministry of Ports & Shipping MoP&S and Transparency International Pakistan(TI-P)for the Implementation of the “**Integrity Pact**”.

MoP&S intends to maintain complete transparency in all activities of the ministry as well as in all organizations under the ministry viz. PQA,KPT,GPA,PNSC, Korangi Fish Harbour Authority, Marine Fisheries Department, and Pakistan Marine Academy, and would like to avail TI-P’s expertise to adopt best practices while following the rules of the Government. Both the esteemed organizations show their commitment to work together to achieve the objectives of this MOU.

By signing this MOU this day both parties hereby agree to the following:

TIP will provide assistance to MoP&S gratis, which will encompass the following:

- Bring to the Knowledge of the Minister the anomalies in implementation of policies, process which may be prima facie violation of law, and the procurements along with recommendations to address them in resulting in compliance to rules, regulations and laws.
- Ensuring tender procedure comply with Public Procurement Rules 2004;
- Tender documents are made available to all qualified interested parties;
- Formation of transparent tender evaluation criteria and vet documents ;
- Vet the tender documents prior to issue to bidders, and make them transparent;
- Complaints, if any, received from the aggrieved party are addressed on merit by the ministry/organizations as per rules;
- MoP&S will ensure that TIP’s observations are addressed promptly.
- TI-P under its charter will not participate in tendering process in any capacity except as an observer.
