Sub: Complaint on allegation of illegal China Cutting of over 50-120 acres land worth over Rs 20 Billion by KPT on Mail Kolachi Road.

Dear Sir,

Transparency International Pakistan refers to its complaint dated 6 August 2013, regarding above issue and the illegal efforts for allotment of billions of rupee worth 75 Acres Land to Sindh Government by KPT, during the caretaker government in April 2013.

On this particular issue, Transparency International Pakistan had requested the Minister of Ports and Shipping to examine the complaint, and take appropriate action, but no action was taken since last two months.

1. KPT Officers Society Land allotted by KPT Board in 1996 is 130 Acres, and by not mentioning it in BR 270 the area of the KPT Society, it appears that KPT Management has ulterior motives to increase the legal Society Land from 130 acres by 40-50 acres for its personal utilization, without legal authority, which shall be addressed with an iron hand.
2. Also hundreds of plots in KPT Officers Housing Society have been allotted to those who are not KPT officers, like Ministry of Ports & Shipping officers, outsiders, etc. KPT Trustees according to KPT Act can not take any advantage from KPT, but dozens of Trustees have been allotted plots. all such illegal allotments shall be cancelled.

On the complaint of Transparency International Pakistan, MOP&S did not approve KPT Board Resolution No 270 (ITEM 1) dated 11-4-2013.

On 8 August 2013, a result of another complaint of Transparency International Pakistan KPT Board cancelled the Board Resolution No 270 (ITEM 1) dated 11-4-2013, of the illegal sale of 75 acres land.

However, recently rumors are spreading in Karachi that few land mafia players with help of local members of PML (N) and officers of Ministry of Ports & Shipping, are trying to get regularized this illegally garbed land worth over Rs 20 billion. According to reports, a Road worth Rs 4 billion is also tendered to be built by KPT on public fund, so that this illegal land is regularized.

The electronic media has also recently been telecasting many programs about this illegal act of china cutting and land grabbing of billion od rupees , which is hurting the Prime Minister of Pakistan's declared policy of **Zero Tolerance against Corruption**.



You are requested to kindly look into these complaints urgently as the credibility of government is at stake.

Kindly take up this and other corruption issues to safeguard the national wealth of over Rs 20 billion, and exchequer money Rs 4 billion being wasted on a Road Project, which is also reported to be manipulated to be awarded to a particular firm by GM (C&W), who has been recently posted from another department.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.
