**Sub: Violation of Public Procurement Rules 2004, For Deputy General Manager, Pakistan Railways, Lahore's Tender Notice for Cycle/ Motorcycle/ Car Stand Reservation Office.**

Dear Sir,

This is with reference to Pakistan Railways Headquarters Office, Lahore's Tender Notice published in daily "The Nation" on 22<sup>nd</sup> Aug, 2018. It is observed that the advertisements are in violation of the PPRA Rules 2004.

As per advertisement, "Railway administration reserves the right to reject any or all bids without assigning any reason thereof", which is violation of PPRA Rules 2004, Rule No. 33. Stated as under:

**33. Rejection of bids:-** (1) *The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.
